Provisions: Fountain Fantasy, Inc will require access to the desired set up area at least 90 minutes prior to your event start time. In addition, 90 minutes is required after the conclusion of Fountain Fantasy's service period for take down and removal of all our equipment. The client is responsible to provide a sturdy, level table capable of supporting at least 150 pounds. Client also agrees to provide two coordinating table linens matching the clients color scheme. Fountain Fantasy requires at least one 120-volt circuit within 10 feet of the desired set up area that adheres to contemporary safety standards and supplies at least 15 amps. Once the chocolate fountain & table have been set up in the desired location, they cannot be moved during the event. One trash receptacle is needed located at the fountain table. Client accepts full responsibility and is liable for any damages, injuries or delays that occur as a result of failure to comply with these provisions. Fountain Fantasy reserves the right to use any photographs or images from the event in its advertising or collateral material.

Payment terms: Fountain Fantasy requires a \$200.00 retainer to reserve both the fountain and your date. To confirm this agreement, keep one copy for your records and return one signed, completed copy of this contract along with your \$200.00 retainer within five (5) days of receipt. Balance is due no later than 14 days prior to your event and can be paid using cash, check, money order or credit card. All checks must be made payable to: Fountain Fantasy, Inc. P.O. Box 850114 Braintree, MA 02185. There is a \$35.00 fee charged for all returned checks. Deposit payment click)

Cancellation: This agreement cannot be cancelled, except in writing, by either the client or Fountain Fantasy. If the client initiates cancellation, then the full deposit, \$200.00 will be forfeited.
